Update on the execution of the buy-back programme

Padua, January 25th, 2021 – SIT S.p.a. (“SIT”, or the “Company”), listed on the MTA market, with reference to the buy-back programme approved by the shareholders on May 6th 2020, and launched on the same date, informs that in the period between January 18th, 2021, and January 22nd, 2021, acquired n. 10.321 SIT’s ordinary shares at an average unit price of EUR 6,5554 per share, for a total amount of EUR 67.658,52.
