Update on the execution of the buy-back programme

Padua, January 31st, 2022 – SIT S.p.a. (“SIT”, or the “Company”), listed on the Euronext Milan market (ex MTA market), with reference to the buy-back programme approved by the shareholders on April 29th, 2021, and launched on the same date, informs that in the period between January 24th, 2022, and January 28th, 2022, acquired n. 5.450 SIT’s ordinary shares at an average unit price of EUR 9,3305 per share, for a total amount of EUR 50.851,03.
