## Update on the execution of the buy-back programme

**Padua, October 28<sup>th</sup>, 2022** – SIT S.p.a. (“SIT”, or the “Company”), listed on the Euronext Milan market (ex MTA market), with reference to the buy-back programme approved by the shareholders on April 29<sup>th</sup>, 2022 and launched with a resolution of the Board of Directors of May 11<sup>th</sup>, 2022, informs that in the period between October 24<sup>th</sup>, 2022, and October 28<sup>th</sup>, 2022, acquired n. 650 SIT’s ordinary shares at an average unit price of EUR 6,1320 per share, for a total amount of EUR 3.985,81.
